##### General notes

Layers, deposits and heaps of combustible dust must be considered, like any other source which can form a hazardous explosive atmosphere. Danger of dust explosion.

Advice on general occupational hygiene

Wash hands after use. Do not eat, drink and smoke in work areas. Remove contaminated clothing and protective equipment before entering eating areas. Never keep food or drink in the vicinity of chemicals. Never place chemicals in containers that are normally used for food or drink. Keep away from food, drink and animal feedingstuffs.

As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.

##### - Breakthrough time of the glove material

Use gloves with a minimum breakthrough time of the glove material: >10 minutes (permeation: level 1).
