4.1 Description of first aid measures

General notes

7.1 Precautions for safe handling

Recommendations

Only vacuum cleaners containing no ignition sources may be used for combustible dusts. Ground/bond container and receiving equipment. Use explosion-proof electrical/ventilating/lighting/equipment. Use only non-sparking tools.

- Specific notes/details

Layers, deposits and heaps of combustible dust must be considered, like any other source which can form a hazardous explosive atmosphere. Dust deposits may accumulate on all deposition surfaces in a technical room. The product in the delivered form is not dust explosion capable; the enrichment of fine dust however leads to the danger of dust explosion. Danger of dust explosion.

Advice on general occupational hygiene
